


State, Religion, and Church is an open-access electronic journal of religious studies published twice yearly in English by the International

Christopher Johnson, University of North Dakota

I am currently teaching as Assistant Professor of Global Christianity in the Department of Philosophy and Religion at the University of North Dakota in a yearly position with hopes for a more permanent place here or elsewhere in the near future. This year, I have several upcoming publications. First, my article "He Has Made the Dry Bones Live': Orientalism's Attempted Resuscitation of Eastern Christianity," should be published in the Journal for the American Academy of Religion. Another article, "Base, but Nevertheless Holy': Lessons in Liminality from Symeon the Holy Fool," is scheduled to be published in Studies in Religion/ Sciences Religieuses. I had another chapter on holy foolishness published in 2013 in Studia Patristica 68. Recently, I have been researching the relationship between Gerald Palmer, the editor of the English Philokalia, and the Russian hermit Fr. Nikon Strandtman in relation to the study of pilgrimage, spiritual direction, mysticism, and transcultural religious exchange. I plan to hopefully publish the correspondence between Palmer and Fr. Nikon and eventually write a monograph on this material. I am giving or have given papers on this research at the 2013 Sophia Institute for International Orthodox Thought and Culture Annual Conference, the 2014 Upper Midwest Regional AAR-SBL, the 2014 North American Patristics Society Annual Meeting, and an invited paper at St. Mary's University of Minnesota. In 2013, I also gave papers on Orthodoxy and Orientalism at the Orthodox Theological Society of America Annual Meeting and the Association for the Study of Eastern Christian History and Culture Biennial Convention.
